## **Budget & Dues**

Currently, the annual/common fee (on all units) is \$500 payable on January 2nd. Additionally, the monthly/limited fee (townhomes only) is \$65/month payable on the 1<sup>st</sup> day of each month. Note that payment of dues is NOT included in your monthly mortgage/escrow and as noted below late fees will accrue on any missed payments.

An initial contribution in the amount of \$750 is charged to new buyers.

Invoices and statements are issued by our accounting firm, Cyron & Company, at the beginning of each month. Each owner is responsible for paying either electronically or by mailing a check

to Northbrook Community Association, P.O. Box 470, West Grove, PA 10390. (Prepayments are appreciated.)

#### Late Fees

Please send your payment on time to avoid late payment penalties which are otherwise automatically applied by the accounting firm.

- For common dues, \$20/month assessed the end of the 2nd month of delinquency
- For limited dues, \$5/month assessed at the end of the 2nd month of delinquency
